B. Curriculum and Instruction

- Middle School Course Proposal True Success
  - a. This will be an action item in a future meeting. True Success is used K-5 and adoption will align K-8 curriculum.
- 2. Math Intervention positions
  - a. Administration recommends the hiring of a math interventionist for Zinser, Central, Alpine Elementaries and KH Middle School. Funds provided by ESSER. This recommendation comes as a result of MICIP-identified needs in math supports.
- 3. Math Coaching position
  - a. This position (1) will support K-5 math educators across the District.
