- A. Superintendent's Report
  - 1. 2022-23 Discipline Data
    - a. Superintendent Hopkins presented data pertaining to the discipline data broken down by building for the 22/23 school year. The complete report can be found in the board packet.
    - The board requested that each building utilize the same disciplinary infractions.
    - d. The board inquired about the number of bullying incidents that are reported across the district. Superintendent Hopkins noted that the results indicate the number or instances where an alleged incident was found to have occured based on the definition of bullying.
    - e. Assistant Superintendent Dinkelmann will work with administrators to provide support in ways to help improve areas of concern indicated by the reported incidents.
    - f. Superintendent Hopkins also noted he held three discipline hearings this academic year compared to 12 discipline hearings in the 21-22 school year.
